Dave,

I spoke with you this morning, and again just a few minutes ago, regarding my meeting on Friday with you and Bobbi Bonnet. During the meeting, Ms. Bonnet made it clear to me that she (and "many others") were "happy" to see KP-CIS "changed" to Epic.

When I spoke with you earlier last week, I had the impression that we would be meeting with a technical expert. Ms. Bonnet clearly has her opinions has some familiarity with the older KP-CIS project in Hawaii. However, during the brief time in which we ventured into a more technical discussion, she indicated that she didn't have direct knowledge of the technical nature of Citrix and HealthConnect.

She also disputed, incorrectly, the timeline I presented for Cliff Dodd's joining the organization, indicating she believed he joined in 2003, not early 2002. She further (incorrectly) asserted that the entirety of the KP-CIS write-off was for Hawaii.

Bobbi Bonnet has some very strong opinions with regard to the issues involved in your investigation. As far as I could tell, the only outcome of our meeting on Friday was to inform me that an important person reporting to Louise Liang was now involved in the investigation, and that she was there to dispute my understanding of these issues.

For what it's worth, the meeting with Ms. Bonnet greatly reduced my confidence in the integrity of this investigation. In the future, if you have questions, technical or otherwise, I will accept them and answer them in writing.
